American Association of Orthopaedic Surgeons Resident Event Passport – Drawing Rules

Resident Members of the American Association of Orthopaedic Surgeons ("AAOS") who complete their Event Passport during the sponsored Resident Event held in Rosemont, IL (the "Event") may participate in a drawing to win one of two Gift Cards (the "Drawing").
