

## **Commercial Representative Registration & Information**

The AAOS 2010 Annual Meeting will be held at the Morial Convention Center in New Orleans, LA, on March 9-13, 2010. Exhibits will be open March 10-12 from 9 AM to 5 PM.

The AAOS Annual Meeting is a closed meeting for medical professionals. However, after review and approval, AAOS does allow a **maximum of two representatives** from a non-exhibiting commercial company to attend the meeting under the registration category of Commercial Representative. Approval is not guaranteed and is at the discretion of the Exhibits Committee.

Registration provides access to the technical exhibits in Halls A-G on March 10-12 from 9:00 AM to 5:00 PM. **Soliciting business on the floor is not permitted.** Disrupting or interfering with presentations being conducted for physicians will result in expulsion from the exhibit floor. The Academy offers access to this closed meeting as a professional courtesy. Commercial Representatives are NOT allowed admittance to AAOS educational programming. Children and individuals under the age of 16 are not allowed in the exhibit hall.

- Potential Exhibitor (one-time registration only)

**Advance Registration: \$1,000** – payable by check only

To pre-register, complete the registration form and return with payment to be received at AAOS by **January 27, 2010**. Approved applications will be sent a letter of confirmation as well as information for making housing reservations through the AAOS housing bureau at our special reduced rates. An Exhibitor Directory, which includes exhibitor contact information, booth descriptions, and product areas, will also be sent. Domestic badges will be mailed prior to the meeting; international badges will be available for pick-up on-site at Exhibitor Registration located in the Hall E Lobby.

**Onsite Registration: \$1,200** - payable by cash, check or credit card

On-site registration is at the discretion of AAOS and will take place at Exhibitor Registration in the Hall E Lobby during the following times: Tuesday, March 9, 1:00-5:00 PM; Wednesday-Friday, March 10-12, 8:00 AM-5:00 PM.
