#### **Attendee Registration**

#### **Exhibitor Badge Registration**

The deadline to pre-register badges to be mailed (U.S. only) is **July 23.** Register your booth staff by logging in to the Exhibitor Dashboard and clicking on the "Badge Registration" tile. To login, use your Exhibitor ID and Password. Exhibitors may register up to a maximum of four representatives for each 100 sq. feet of exhibit booth space. There will be no additional badges provided or sold over this allotment. View the *Health & Safety Requirements* below for details on the health attestation program.

#### **Exhibit Insurance**

Every exhibitor is required to have general liability insurance coverage of their exhibit booth materials against damage and/or loss and against personal injury and property of others. Each exhibitor must supply their Certificate of Insurance (COI) showing evidence of their insurance policy by **August 2.** Exhibitors can submit their

COI to or purchase a policy from the official vendor, Rainprotection Insurance. Exhibitors who have not supplied proof or purchased insurance by **August 2** will be automatically enrolled in Rainprotection's insurance program and will be billed \$85 by AAOS.

#### Freeman Orders

The discount deadline for all Freeman orders (carpet, electricity, furniture, A/V, etc.) is **August 4**. To place your orders, visit the **Freeman website**.

#### **Catering Orders**

Food and beverage can be ordered via the official catering vendor, Centerplate. Orders are due by **August 6**. Exhibitors are not permitted to bring any outside food or beverage into the exhibit hall.

#### **Exhibit Hall WiFi**

AAOS will provide complimentary basic WiFi throughout the exhibit hall. Access details will be provided in August. For exhibitors requiring a more robust or private network, place your order via the official internet vendor, Smart City. Be sure to place your order by August 10 for discounted pricing.

#### **Health & Safety Requirements**

Guided by the State of California mandates for meetings and events over 5,000 people, AAOS is requiring ALL attendees and exhibitors from the United States to provide proof of vaccination or a negative COVID-19 test result within 72 hours of the first day of arrival at the Annual Meeting. International exhibitors and attendees will only be allowed to attend if fully vaccinated.

To meet this requirement, AAOS has partnered with Safe Expo to implement its health attestation program. Safe Expo's dedicated online portal will help AAOS collect proof of vaccination from all participants in an accessible, privacy-preserving manner that will save time for exhibitors and attendees. All attendees and exhibitors are encouraged to submit proof of their CDC-issued vaccination card in advance of arriving in San Diego.

Save time and pre-verify today!

NOTE: Exhibitors who prefer to verify their vaccination onsite, or plan to provide proof of a negative COVID-19 test administered within 72 hours of traveling to the event, should bring proof to the Health Screening Station onsite at the San Diego Convention Center.
