SPACE ASSIGNMENTS AND FEES

EXHIBIT SPACE ASSIGNMENT FOR APPLICATIONS RECEIVED BY SEPTEMBER 1, 2023

Applications for exhibit space must be submitted online. On the application, exhibitors should rank their preferred room locations between the Kokopelli Ballroom Foyer, the Food & Beverage Room 1 and the Food & Beverage Room 2. Exhibit locations will be assigned based on priority point order, past exhibit participation at the Sports Medicine Course, and the date the application is received. To be included in the first round of space assignments, the application and 50% deposit must be received by **September 1, 2023.** Applications received without the deposit will not be assigned space until the deposit is received.

Exhibits are available in three locations:

- Kokopelli Ballroom Foyer \$4,600
 The main lobby area where attendees will enter and exit the Kokopelli Ballroom. The Ballroom is where didactic lectures take place.
- F&B Rooms 1 and 2 \$3,600

 These rooms are where food and beverage service are located. Attendees will visit these rooms during the numerous breaks throughout the course.

EXHIBIT SPACE CANCELLATIONS

ADDITIONAL BADGES

Two (2) badges are included in the exhibit space fee. Up to three (3) additional badges may purchased for

All exhibitor representatives must register and wear the official exhibitor badge for admission to and while at the course. Exhibitor badges are to be issued only to company employees, and/or any other individuals working in the exhibit booth.

EXHIBIT SPACE REQUIREMENTS

All exhibits must be confined to the space limits as indicated on the floor plan. All equipment, products, or materials to be displayed or demonstrated must be placed on the exhibit table and chairs must be positioned behind the table. Exhibits are subject to show site review and modification where necessary, at the exhibitor's expense.

HOTEL INFORMATION
